Larry Paine Honored with APPA 'Seven Hats' Award

KPP Board President, and Hillsboro City Administrator, Larry Paine, received the Larry Hobart Seven Hats Award at the American Public Power Association's national conference Austin, TX earlier month. The ar terent earlier this the award in managers recognizes of small utilities serving fewer **APPA** than 2,500 meters. notes that these managers have a very small staff and must assume multiple roles.

In an award presentation on June 11th Larry was recognized for his duties in overseeing planning, design, finances electric, water, and wastewater utilities in Hillsboro. His tenure of almost 12 years in Hillsboro, and in similar or identical roles elsewhere in Kansas and the U.S., was also noted.

On the 2019 KMU calendar, this award

followed the culmination of Larry's service as its Board President and his receiving of the Edgar Showalter award from KMU.

KPP Board Approves Ongoing Funding for Cyber Analyst

Meeting by teleconference on June 10th, the KPP Board of Directors meeting agenda included discussions on advancing cyber security within the Pool. James Ging and Brooke Carroll updated the Board on the current status of the APPA/DOE Level 1 Cyber Analyst Grant. Brooke mentioned that recent discussions with APPA had produced both questions and strategies for obtaining the grant funding.

The proposal would obtain funding for an Analyst to be utilized by KPP Members. In setting up and evaluating cybersecurity programs within KPP Cities, the position would be contracted through Custom Internet Service. The budget proposal for the Analyst would be approximately

\$72,800 annually. The APPA/DOE Grant would cover 80% of the cost for only the first year. James reminded the Board that \$80,000 is currently being budgeted annually for cybersecurity.

How the program would be sustained after the first year was a concern from APPA and the DOE. Brooke explained that APPA is more likely to approve the grant knowing KPP is prepared to sus-



tain it in future years. Conditioned on a percentage of required participation by Members, Board approval was unanimously given. In KPP's budgetary process, it is expected that funds will be allocated in future years to perpetuate cybersecurity in KPP cities.

APPA CEO Kelly to Headline Speakers at Retreat

National and International Speakers Again to be Featured

When KPP members again gather for the Fall Planning Retreat in September, Sue Kelly will lead off with what is expected to be a stirring message of optimism and encouragement. As President and CEO of the American Public Power Association, Sue has been witness, proponent and leader in many of the positive and striking industry changes during the past 10 years.

Many will remember Sue's attendance at the 2018 KPP Member Appreciation Dinner when she was an invited guest. However, following her announced intention to retire at the end of 2019, KPP sought again to extend an invitation – this time for a speaking role.

Under Sue's leadership, APPA has been influential both legislative and regulatory developments affecting our industry. Within the APPA family, advancements have been made elevating smart energy, distributed energy resources and the acceptance of emerging technologies. She has also led in advanc-



ing cyber security readiness and reduction in carbon emissions. Indeed these were among her comments on critical issues when she spoke at the APPA National Conference in Austin, TX earlier this month

As noted in APPA's *Public Power Daily*, Sue acknowledged Public Power's reductions in carbon dioxide emissions by 33 percent between 2005 and 2017 and encouraged continued vigilance and innovation. "If we can help our customers use electricity more efficiently, electrify new loads like transportation, and incorporate more lower carbon resources into our power supplies through the use of battery storage and demand response, we can do still more."

The Conference concluded with the announcement of the newly created Community Service Award named after Sue and in her honor.

'Let Me Talk to the Mayor!'

Editor's Note: In February KPP introduced this new segment to the <u>Lightning Round</u>. Each month, our intention is to report on a Q&A between CEO/General Manager Mark Chesney and the mayor of a KPP Member City. This edition features Mayor Darrell Bauer of Erie.

Mark: In all the years I have known you, I have never asked if you are a life long Erie guy. Could you tell me about your growing up?

Darrell: I grew up on a farm near Elsmore, Ks with my parents, 2 brothers and 2 sisters. My parents instilled a strong work ethic in us kids at a very young age. Back then if you distribute young age. Back then, if you didn't work-you didn't eat! As a young man, I navigated to Erie in 1960 because a lovely young woman named Linda lived there. Linda and I got married and raised our 3 children right here in Erie. Erie is home to me - I've raised my family here and buried my wife and a son here.

Mark: I'm sorry. I had known you lost your wife but I did not know about your son.

Darrell: The outpouring of support from the community following their deaths is why I feel such a connection to Erie. When I recently re-married, my new wife Janet graciously left her home in Texas to move here to

> Erie just for me. Mark: So what significant changes have you seen in Erie over the years?

Darrell: The most significant changes I've seen over the years is this community's investment in infrastructure such as in street improvements, city park improvements, a nice new housing addition, and a modern high school. Other changes I've noticed through the years are the decline of "mom and pop" businesses due



to the mobilization of society.

Mark: Yes. vou and I have that in common!

Darrell: I remember a time when people couldn't just drive out of town to go shopping whenever they wanted, they had to either grow their own or buy it right here in town

Mark: As you know, I have been to many of your governing body meetings. I like the

way you run them. But I have to tell you, I heard a rumor that you do not intend to again run for reelection. What was going on in Erie when you were initially motivated to run for office?

I ran for mayor to get involved in the community. Some people run because they have an agenda of some sort or something they want changed. My philosophy is to not just sit on the sidelines and gripe about things-it's better to get involved and "make good or make room, but don't make excuses"!



In your years as mayor, what do you think are some of the important lessons you have learned about the interests of citizens?

Darrell: I think the best lesson I've learned about the interests of the citizens during my time as mayor is being more compassionate to their concerns. People just want to be heard and to know that you do care about what they have to say.

Mark: I have observed that your Council is very polite and accommodating to citizens. Can you give our newsletter readers an example of a time where cooperation by the City has made has further endeared a citizen or citizen group to the City?

Darrell: The most recent example is following all this flooding. When a citizen called needing help with clean up, the city crew was there to lend a hand. The city crew also hauls off debris and limbs for citizens after strong wind storms. The council also financially supports many worthwhile causes and committees that will benefit the majority of the citizens of Erie.

Mark: Do you have any predictions for Erie or for "small-town-America" generally?

Darrell: If people don't get involved and continue to work hard to preserve our way of life, there won't be any "small-town-America"!

It's a simple question: have you completed it? We know that many have but not all. The Cybersecurity Scorecard is an online self-assessment tool for Public Power utilities. It helps to assess cyber risk, plan improvements, prioritize investments and benchmark their security posture. Developed by the American Public Power Association (APPA) and its partner, Axio, it is an excellent starting point to address cyber risks.

With each passing day, we are all increasingly left without excuses as we feel urgency in addressing threats to our information systems. Fortunately, KPP can help in providing guidance and tools for assessing and establishing readiness. Many KPP Members completed our recent Municipal Cyber Academy. There, Cities discovered how KPP helped them to either start their cybersecurity journey or evaluate ongoing efforts.

Attention all Members! Power Supply Update Planned for August 6th!

All KPP Members are urged to be in attendance on August 6th at the KMU Training Center in McPherson for an important update on power supply planning. As steady progress has been made on replacing contract resources, the cost impact and future anticipated revenue for this project will again be topics for discussion.

Two similar gatherings came together last year in McPherson during April and August preceded by an earlier update in March 2017. Related discussions also occurred at the Fall

Planning Retreat last September. Beginning with membership approval given in 2018 for a formal site location and economic study, progress has been made in refining cost and revenue projections as well as resource adequacy for future years.

The final phase of the study is expected to be completed by the end of June.
